- 3.1. Area Director's Report: Sonia/Ian absent
- 3.2. President's Report: Bruce
  - 1) Chief Caroline Harry indicated interest in being here but didn't join us at the AGM
  - 2) Completion of EBCP main agenda rationale for the tax allocation
  - Draft report of MoE much collaboration and effort went into this water study including \$2500 of SBS funds – we now have a baseline
  - Contaminated site diverted entire community's energy toward the fight office supplied by SBS
  - 5) Foreshore to Forest project initiated by Jenny Berg with a foreshore inventory Aviva \$5000, which will be included on the new website funds received through CLTS
  - 6) Board of SBS are now members of the CLTS Bruce is also their Board member extremely helpful group
  - 7) SRA collaboration with SBS re introduction of water plan meeting on March 15 at 5 pm
  - 8) Also invited them to consider collaboration a Basin Authority able to approach government perhaps under the new water act – appointed Jerrod and Grant Price – created Authority as a community driven ecological governance approach and foundation for future incorporation
  - 9) Working on a comprehensive plan for water sampling (ground water) Linda talking with professionals for guidance on this process MoE, individuals, Andrew Weaver all needs to be regularized into a usable package dealing with SIA and future understanding MoE ought to be insisting on but are not developing our internal capability plan to seek partners to deliver it Kelly continuing to write grant applications
  - 10) With Grant's help, we had a workshop with the APC developing of evaluation criteria using EBCP as foundation of rationale

- 11) Met with Parks and Rec proposed they review their master plan in relation to the ecosystem based plan and see how well they match, maybe change their priorities, consider the overlap of their agenda with the final report created by Herb
- 12) Kelly and Doug working on the Administrative requirements of the SBS ie CRA Jenny will be paid for some of her work from the Aviva grant as well as SBS
- 13) Liaising with Koksilah (Area E) with Emily Doyle-Yamaguchi as they are proposing the same kind of work already achieved by the SBS Bruce now a member of their Board they have talked with the planning department of the CVRD to have this work integrated with their new OCP (Cowichan Station Community Association?) stage 1 of their application, stage 2 invited to submit an application
- 14) A number of presentations Emily and Bruce ie Cowichan Round Table, a class of VIU students and the Cowichan Watershed Board ie what's going on in Shawnigan as well as Herb's work
- 15) Ongoing trekking in which two hazards occurred with Barry (Cliff, Ed, and Dave fell 10 ft, disappeared) and Cliff (broke his leg after putting his foot in a hole on one of these expeditions)
- 16) SIA has sapped money and time from all members of the community and we wait
- 17) A watershed that needs all the attention we can give it on all fronts
